**Bioethicist by training but a practical philosopher by imprinting, very fond of participatory approaches & deliberative methods**. From the very beginning of my career, I understood bioethics as a democratization of science practice, as well as science as a responsible and open process working for innovative and inclusive governance. With enthusiasm I face the challenge to accordingly rethinking training models regarding multi-actor empowerment and engagement and framing research within a Responsible Research & Innovation - RRI Horizon.

In the last 25 years, as a senior bioethicist, Ethical-Legal-Societal trainer, and consultant for both private and public organizations, I have been promoting and coordinating at national and international levels participatory, multidisciplinary actions both in science and medicine fields involving the diverse actors at stake, besides recognizing patients and citizens as partners. Some pioneering contexts have been vital training grounds for my professional and methodological path. I was on the front line with the Rare Disease community for the Stamina affair, the Beta-Thalassemia community coediting the informed consent to the GLOBE Genetic "Therapy" 1st Phase Trial, and the Translational Medicine Hospitals, the IRCCS. Moreover, I learnt much working in the field with many special vulnerable groups such as African immigrant women to step forward infibulation, soldiers in Cyprus to mitigate potential abuses in sample-and-data-based research and children as participants in the research processes.

Here, I took on the challenge of building a Common Service - CS ELSI and enhancing translational biobanking integrated with healthcare. Since joining the ESFRI world in 2011, I have played a key role in establishing the national node and the CS ELSI at the European level, furthering my commitment to infrastructure research processes and governance.

For the past ten years, I have been part as an **expert bioethicist of the ELSI Services & Research Unit** at the Head Quarter of BBMRI-ERIC while **coordinating ELSI and ELSI Help-desk activities at the national level for BBMRI.it.**
